

Privacy Policy

Basic Concepts

Website - a website located on the Internet at <https://bulltech.ru/>

Site Administration - limited liability company BULLTECH, located at the address: Moscow, Zelenograd, st. Yunosti, house 8, floor 9, office 902.

User - a user of the Site, a person on the site.

Policy - this Model Privacy Policy for the use of requested data.

Using the site <https://bulltech.ru/> means the user's unconditional consent to this Policy and the terms and conditions specified therein processing of his personal information; in case of disagreement with these conditions the user must refrain from using this resource.

1. General Provisions

1.1. This Policy is an official standard document and determines the procedure for processing and protecting information about individuals, using the Site Resource.

1.2. The purpose of this Policy is to ensure adequate protection of information about users, including their personal data, from unauthorized access and disclosure.

1.3. Relations related to collection, storage, distribution and protection information about users are governed by this Policy and the current Russian legislation.

1.4. The current version of the Policy, which is a public document, developed by the Site Administration and available to any network user Internet when clicking on the hypertext link "Privacy Policy". The Site Administration has the right to make changes to this Policy. The Administration is not obliged to notify users about making changes to the Policy.

1.5. The user agrees with terms of this Policy while using the Site Resources.

1.6. If the user disagrees with the terms of this Policy, the usage of the Site Resources must be stopped immediately. Within the framework of this Policy under "personal user information" are understood: users' name, phone number and e-mail address.

2. Terms of use of the Site Resources

2.1. By providing services for the use of Site Resources, the Site Administration, acting reasonably and in good faith, believes that the user:

2.1.1. has all the necessary rights to allow him usage of the Site Resources;

2.1.2. indicates reliable information about himself which is necessary for use of the Site Resources;

2.1.3. realizes that some types of conveyed information during using the Site Resources cannot be deleted by the user himself;

2.1.4. has read this Policy, agrees with it and assumes the rights and obligations specified therein.

2.2. The site administration does not check the accuracy of the information received (collected) information about users.

3. Purposes of information processing

The site administration processes information about users, including their personal data, in order to fulfill the obligations of the Site Administration to users regarding use of Site resources and providing users with current and summary information.

4. Composition of information about users

The site administration can process information about users that includes:

4.1 Personal data of users provided with users' consent and necessary for using the Site Resources: IP address, information from cookies, information about the user's browser, time of the requested information, name, contact phone, email.

4.2. In general, the site does not check the accuracy of personal information provided by users, and does not exercise control over their legal capacity. However, the site <https://bulltech.ru/> assumes that the user provides reliable and sufficient personal information on the issues proposed in the forms of this resource and keeps this information up to date.

5. Processing of users' personal data

5.1. The processing of personal data is carried out based on the following principles:

5.1.1. the legality of the purposes and methods of processing personal data and integrity;

5.1.2. compliance of the purposes of processing personal data with the purposes, defined in advance and declared when collecting personal data, as well as powers of the Site Administration;

5.1.3. compliance with the volume and nature of the processed personal data, methods of processing personal data and purposes of processing personal data;

5.1.4. inadmissibility of combining those created for incompatible purposes of databases containing personal data.

5.2 Conditions and purposes of processing personal data

5.2.1. The site administration processes personal data of the user with his consent in order to provide services to the user by use of Site Resources.

5.3. Collection of personal data

5.3.1. User's personal data provided for in clause 5.1 of this Policy are transferred to the Site Administration with the consent of user. User's consent on transfer of his personal data to The site administration is provided in the form of mandatory actions at the first user downloading of Site Resources.

5.4. Transfer of personal data

5.4.1. Users' personal data is not transferred to any third parties, except for cases expressly provided for in this Policy.

Providing personal data of users at the request of government officials bodies (local government bodies) carried out in the manner prescribed by law.

5.5. Destruction of personal data

5.5.1. The user's personal data is destroyed upon deletion by the Site Administration, provided by the user from their electronic media after their validity period has expired;

5.6. Personal information of users received by the Site Administration is not may be available to other users.

6. Rights and obligations of users

6.1. Users have the right:

6.1.1. Provide unlimited free access to the Site Resources, updating information about themselves;

6.1.2. based on a request, receive information from the Developer, regarding the processing of his personal data.

7. Measures to protect user information

The site administration takes technical, organizational and legal measures to in order to ensure the protection of the user's personal data from unlawful or accidental access to them, destruction, modification, blocking, copying, distribution, as well as from other illegal actions.

8. Limitation of the Policy

This Policy applies only to the site <https://bulltech.ru/> and not applies to the actions and Internet resources of third parties, to which the user can follow the links available on the website <https://bulltech.ru/>. Such sites may collect or request other personal information from the user, and other actions may also be performed.

9. User requests

9.1. Users have the right to send their requests to the Site Administration, including requests regarding the use of their personal data, provided for in clause 7.1.2 of this Policy, in writing to the address specified in the "Contacts" section in the form of an electronic document signed by qualified electronic signature in accordance with the law of The Russian Federation, at the email address specified in the section "Contacts".

9.2. The request submitted by the user must contain the following information:

9.2.1. number of the main identification document of the user or his representative;

9.2.2. information about the date of issue of the specified document and the issuing authority;

9.2.3. information confirming the user's participation in relations with The site administration (in particular, information about loading one of the site resources on personal email address used by the user when using the Site Resources);

9.2.4. signature of the user or his representative.

9.3. The site administration undertakes to review and send a response to received user request within 30 days from the date of receipt of the request.

9.4. All correspondence received by the Site Administration from users (appeals in written or electronic form), refers to restricted information and will not be disclosed without written consent of the user. Personal data and other information about the user, who sent the request cannot be without special consent of user, and used otherwise than to respond to the topic of the received request or in cases expressly provided for by law.
